On our website new developments and information about the schemes and the dates on which samples are sent out, can be found. For schemes not yet implemented in Qbase, report-forms can be downloaded and after the deadline (provisional) results can be seen here.

Qbase/Muse

All results are entered in Qbase(vs. 5) and Reported in Muse, except for the Drugs of Abuse (DOA) and Toxicology. But we are working on also implementing these into the software.

Volume of the samples

New is that the samples in the schemes and also the optional control samples will have a (reconstitution) volume of 3 mL instead of 5 mL, the standard until now. This way we can freeze-dry in a more efficient way.

Control sera

Control sera are only available for subscribers to the matching program. Control sera have to be ordered separately when subscribing to a certain scheme for the coming year. We prepare only a certain amount of control sera according to the number and volume of orders for the coming year. Therefore extra orders during the year can only be granted on a limited scale, i.e. as long as available. We will charge extra for administration and postage for orders during the year.

N.B. KKG T-control sera are not meant to be used instead of your own calibrators. A correct procedure would be to measure the control sample on your own calibrators and then judge any action necessary for the results of the other samples in this series. There is **one exception: gentamicin**.

Your result for gentamicin in the KKG T-antibiotic scheme should be corrected for the result of the control sample. This because gentamicin is a mixture of components without a fixed composition. The batch of gentamicin used for preparing the KKG samples may vary from the one your calibrators are prepared from. Resulting in a slightly different result. Per round one vial of control sample is send along so you can correct the result from the gentamicin determination in the KKG T scheme. This way results can be better compared as far as variance is concerned. However the matter of trueness cannot be solved this way.

Latest developments

- *Anti HIV drugs II*

Dolutavir and elvitegravir will be added to the samples.

- *Drugs of Abuse*

As requested by some participants once in a while paracetamol and a (tri-cyclic-) antidepressant will be added to the test sample. Because some labs use the tests involved also for these components in a clinical situation and want to check the results.

- *Benzodiazepines*

Also on request to the scheme will be added an extra sample containing diazepam and metabolites: desmethyldiazepam, temazepam and oxazepam. Of course we will also supply a control sample with these four benzodiazepines.

- *Biologicals*

The possibilities for a scheme are being investigated. At this moment we cannot tell any more.

- *Psychotherapeutic drugs I*

The metabolite of nortriptyline: hydroxynortriptyline will be added to the sample.
